Nikhil Singh** CDO/IE Unit lodged a written report to OC/APS at 01:45 pm stating that on the same day i.e. the 2nd July, 2025 at about 5:30 a.m. received a credible information from their own intelligence corroborated with the intelligence of 5/9 GR about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Andro Khuman and its adjoining foothill areas of Imphal East District. Based on the said information a combined team of CDO/IE Unit assisted by Sub. JC No. 731 K. Ibungobi Singh of 7th IRB/CDO/IE Unit and 5/9 GR along with a team of Andro PS, under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal East Unit and under the supervision of Shri. Ak. Sadananda Singh, MPS, in charge Addl. SP (Ops) Imphal-East District rushed to the said area and conducted a searched operation at 6:30 a.m. During the search operation, the undernoted arms, ammunitions, explosives and others items were found hidden in a bush at the foothill of Andro Khuman Baruni hill, Imphal East District. (1) 1 (one) no. of .303 rifle marked as '34662.' with magazine. (2) 1(one) no. of 9 mm Pistol marked as 'D-2135' with magazine. (3) 1(one) no. of 9 mm Pistol with magazine.
