I have the honour to report that today i.e. the 6th July, 2025 at about 12:30 p.m. received a reliable information from Cyber Crime Unit, Imphal East (CCU/IE) corroborated with our own intelligence about the presence of some anti-social social elements at Keibi area of Imphal-East District. Based on the said information, a combined team of CDO Imphal East Unit and 28 AR, conducted a C. I. Ops. at Keibi area of Imphal-East District under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Ak. Sadananda Singh, MPS in Charge Addl. SP(Ops)IE at about 1:30 p.m.

In that, one suspicious scooter was detained for spot verification at Keibi Heikak Mapan Awang Leikai, Imphal East District.
