Sir,

I have the honour to report that today i.e. the 1st August, 2025 at about 2:00 a.m. received a credible information from our own source about the presence of an active cadre of the outfit PREPAK at Uyumpok area of Imphal East District. Based on the said information, combined team of CDO/IE Unit and 28th AR led by Major Mohit Dudi under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE, rushed to the said area and conducted a searched operation at Uyumpok Maning Leikai, Imphal East District at about 3:00 a.m.

In that, one suspicious unknown person was detained for verification at a house at Uyumpok Maning Leikai, Sagolmang PS, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one Lisham Sanayamba Singh @ Thangjingnganba @ Thoujal (33 years) S/o L. Nungshibi Singh of Uyumpok Maning Leikai, Sagolmang PS, Imphal East District. On further verification, the detainee stated that he joined the said outfit through one Mr. Japan of PREPAK (Red Army) in the year 2007 and got his basic military training for three months under the command of one s/s – Corporal Mr. Semdokpa of PREPAK (Red Army) with allotted army no. 32137 of 34th batch of the year 2007. The detainee further stated that he is presently holding the rank of s/s – Lieutenant and working under the command of one s/s – Colonel Mr. Romi Meitei of PREPAK (Red Army).

On further examination, the detainee stated that he is also working under the command of one s/s General Secy. Mr. Thonglenjao @ Haona of KCP (PWG) and directly involved in extortion activities of the outfit KCP (PWG) group. Further, it came to learnt that he kept conceal 5 (five) nos. of Demand Letters of the outfit KCP (PWG) group at his house, inside his bedroom, which were handed over to him by one unknown person who was being sent by the said Mr. Thonglenjao @ Haona of KCP (PWG) about 10 days before at Khurai Lamlong Bazar, Imphal East District. Later, on production of detainee from underneath the mattress of his bed, 5 (five) nos. of Demand Letter of KCP (PWG) group were recovered.

In the above facts and circumstances, the detainee was arrested from his residence i.e. Uyumpok Maning Leikai, Sagolmang PS, Imphal East District at 3:50 a.m. and seized: (i) 5 (five) nos. of Demand Letters of KCP (PWG) group duly signed by one s/s - Deputy Finance Mr. Inunganba Luwang of KCP (PWG) and (ii) One mobile phone (Oneplus Nord CE 3 Lite 5G) bearing IMEI no. 860830060462354 & 860830060462347 along with two nos. of Airtel SIM card having nos. 8132869248 & 7085762321 from his residence i.e. Uyumpok Maning Leikai, Sagolmang PS, Imphal East District at 3:55 a.m. by observing due formalities. Therefore, the arrested person along with the seized item are being handed over to you for taking up further necessary legal actions against him.
