Complainant namely ASI **Md. Firoz Shah** of BPR district (Now attached with CDO-IW) lodged a written report to OC/APS at 12:20 pm stating that yesterday i.e. 12/08/2025 at around 08:00 pm, a reliable information was received from their own source and further corroborated from the information input provided by 33 AR regarding the presence of some active members of KCP organization, an outlawed banned organization in and around Nungaipokpi area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a combined team of CDO-IW and a column of 33 AR led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Nungaipokpi Maning Leikai area. During that one suspected person was detained at a house located at Nungaipokpi Maning Leikai. During spot





verification, the detainee identified himself as Sharangthem Sanatomba Singh (41 yrs.) @ Amuthoi s/o Sharangthem Ibobi Singh of Nungaipokpi Maning Leikai, Imphal East District (who later identified himself as the resident of the house). During preliminary verification, he disclosed that he is an active member of KCP(PWG) organization (a faction of KCP organization) and joined the said organization in the year 2023 through one Ranjit @ Poirei of KCP(PWG) organization. He also disclosed that he is presently working under the command of the above mentioned s/s Commander Ranjit @ Poirei (Ph. No. 8837443584/8787507441/8731969894) of KCP(PWG) organization (now staying in Nepal). He further disclosed that he is involved in sharing contact numbers of different individuals to his commander for illegal settlement of cases related to crime against women, money lending cases etc. He further disclosed that he also shared the contact numbers of officials of PHED, Manipur of valley area to his commander to be used in serving monetary demands/threats. Hence, he was arrested from the spot i.e., from his residence at 10.03 pm by observing necessary formalities. From his possession, (i) one Samsung Galaxy A33 5G mobile handset along with two Airtel SIM cards bearing mobile nos. 6002052513 and 8011174798 (as disclosed by him) and (ii) one Aadhaar card bearing no. 2512 6251 6508 were seized at 10:11 pm by observing due formalities. Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
