I have the honour to report that today i.e. the 13<sup>th</sup> August, 2025 at about 3:20 p.m. received a credible information from our own source corroborated with the intelligence of 2/8 GR about the presence of an active cadre of the outfit KCP at Pangaltabi Village of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Shri Khumanhem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a random frisking and to the suspected passersby at about 4:10.m.

In that, one unknown suspicious person was detained for spot verification at Pangaltabi Makha Leikai, Imphal-East District. On verification, the detainee identified himself as one Pukhrambam Ngongo Meitei @ Nungshiba (28 years) S/o (Late) P. Surjit Meitei of Yumnam Patlou Mayai Leikai, Sagolmang PS, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit KCP (MFL) group, joined through one Mr. Naoba of KCP (MFL) in the month of December, 2023 and got his basic military training for one month under the command of one s/s 2<sup>nd</sup> Lieutenant Mr. Punshiba of KCP (MFL) group. The detainee further stated that he is presently holding the rank of s/s – Private and working under the command of one s/s – Lieutenant Mr. Thenga of KCP (MFL) group.

So, the detainee was arrested from the spot i.e. Pangaltabi Makha Leikai near waiting shed, Imphal East District at 4:50 p.m. by observing due formalities. Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
