Complainant namely SI H. Birchandra Singh of Andro PS lodged a written report to OC/APS at 07:20 am stating that today i.e. the 19<sup>th</sup> August, 2025 at about 05:00 a.m. received a credible information from our own intelligence about the concealment of a huge nos. of arms and ammunitions by unknown arms merchants in general area of Ngariyan Chingyang and its surrounding area of Imphal East District. Based on the said information, a team of Andro PS under the command of Inspector N. Premjit Singh OC/Andro PS along with a platoon of F-Coy 189 Bn CRPF led by Inspector Sanjeev Padhan under command of Sh. Ajay Yadav Assistant Commandant of F-Coy 189 Bn CRPF conducted a searched operation jointly at 5:40 a.m. at Ngariyan Chingyang and its surrounding area of Imphal East District under all supervision of Senior Superintendent of Police, Imphal East District. During the search operation, the undernoted arms, ammunitions and others items were found hidden in a bush, wrapped by sack bag, white in colour at the foothill of Ngariyan Chingyang near Larambi near Don Bosco School, Imphal East District.
