I have the honour to report that today i.e. the 14th August, 2025 at about 4:00 a.m. received a credible information from Inspt. Md Rajib Khan, In-Charge Cyber Lab Imphal East about the concealment of a huge nos. of arms and ammunitions by unknown arms miscreants in general area of Uyumpok village, and its adjoining foothill areas of Imphal-East District. Based on the said information, a combined team of Cyber Lab IE, CDO/IE, 4 AR, and 189 Bn. CRPF under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE conducted a searched operation at 5:00 a.m. at Uyumpok village and its adjoining foothill areas of Imphal-East District.


