Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit, Andro PS, 165 TA and 5/9 GR conducted a searched operation at the said area under the command of Shri. Khumanthem Oinraj Karan, MPS, Dy SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 5:00 p.m.

During the search operation, the undernoted arms, ammunitions, explosives and other items were found hidden in a bush at the foothill of Huikap Makha Leikai near Oil Pump, Imphal East District.
