Today i.e. 04/05/2025 at 04:10 pm, a house to house CASO (Cordoned and searched operation) was conducted at Kairang Chingya, Heingang PS/IE led by me along with 64/F SSB station at HNG-PS,IE and standby team of Heingang PS,IE. That, during the search at the residence of Md. Maner @ Taton (40) yrs S/o Md. Gaffar of Kairang Chingya, IE the following illegal drugs i.e. Heroin No. 4 powder (as disclosed by the owner of the house) was found i.e. (1) 10 Nos. of small vial filled with Heroin No.4 (2) one small transparent plastic bottle of 180 ml capacity with blue colour cap written Amul filled upto about 75 % with Heroin No. 4 powder packed in a small black polythene bag, (3) 70 (seventy) Nos. of empty transparent small vial (use in selling illegal No. 4 drugs) properly packed in a small transparent plastic bag. Accordingly, he was arrested from his residence at 05:00 pm and seized the above illegal drugs and a sum of Rs. 5,350/- (five thousand three hundred fifty)only, which was illegally earned by selling the illegal drugs, at 05:05 pm.

That, on conventional weighing of all the seized illegal drugs it is found to be 35 grams including the weight of the small plastic containers.

Hence, a regular case has been registered under FIR No. 34(05)2025 HNG-PS u/s 21(b) ND&PS Act for investigation.
