Subject: Complaint Regarding Unnatural Death of Hidam ningol RK ongbi  
Sanatombi Due to Domestic Violence

Respected Madam,

I, Hidam Nehru Meitei, son of Hidam Shitanjit Meitei, resident of Langdum Mayai Leikai, am writing this letter with deep pain and grief to lodge a formal complaint regarding the unnatural and suspicious death of my sister, Hidam ningol RK ongbi Sanatombi, age 39 years, wife of RK Rishikanta, age 41 years, resident of Waiton Mayai Leikai, Imphal East.

On 09/05/2025, My sister was found hanging in the Shop, run by matrimonial home. The family was informed that she had committed suicide. However, based on multiple incidents in the past and the suffering she had silently endured, we firmly believe that her death is the direct result of persistent domestic violence and mental harassment inflicted upon her, especially by her mother-in-law, RK ongbi Maipakpi.

My sister had frequently shared with us, through phone calls, that she was being mentally and physically abused by her mother-in-law. She had expressed fear and helplessness on several occasions. Last year too she had come to my resident and stayed for 2 months because of the conflict between her mother in law and other family members. She was subjected to constant verbal abuse, threats, and humiliation within the household, and we believe this prolonged mental torture pushed her to take such a tragic step, or worse, that the hanging was staged.

We request you to kindly:

1. Register an FIR under relevant sections of the BNS including abetment of suicide and domestic violence.
2. Conduct a thorough investigation into the circumstances leading to her death. Examine the role of her mother-in-law and any other family members involved.
3. Ensure that justice is served and the guilty are held accountable.

We humbly seek your immediate attention and necessary legal action in this grave matter.
