Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/05/2025 at about 12:35 pm, a reliable information was received from 33 AR and 4 AR and further corroborated from our own source regarding the presence of some active cadres of PREPAK organization in and around Koirengei area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a combined team of CDO-IW and CDO-IE under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and Shri Y. Joyraj Singh, MPS, Addl. SP(Ops.)/IE and under the overall supervision of Shri Rakesh Balwal, IPS, Sr. Superintendent of Police, Imphal East District and Shri Ksh. Shivakanta Singh, IPS, Superintendent of Police, Imphal West District rushed to the said area and conducted search operation at Koirengei Kabui Khul area. During that two suspected persons were detained for spot verification and checking near Koirengei Kabui Khul Gate. During spot verification, they identified themselves as (i) Khangembam Apui Meitei (26 yrs.) @ Nongpoknganba S/o (L) Kh. Ebocha Meitei of Sagang Bazar, Churachandpur District a/p Thinungei Makha Leikai, Bishnupur District and (ii) Moirangthem Alex Meitei (23 yrs.) S/o (L) M. Tomba Meitei of Maharabi Awang Leikai, Imphal West District.

During preliminary verification, Khangembam Apui Meitei disclosed that he is an active member of PREPAK organization and joined the said organisation through one Nongthang of PREPAK organisation in the year 2024 and got Basic Military Training for 45 days at Kakching area in the year 2024.

And Moirangthem Alex Meitei disclosed that he is also an active member of PREPAK organization and joined the said organization through one Thouna of PREPAK organisation from Thangmeiband area in November, 2024 and got Basic Military Training for 30 days at Kakching Khunou.

Further, both of them disclosed that they are presently working under the command of one s/s Camp Commander Ningthem @ Ngamba (Ph. No. 8798953121) of PREPAK organization of Kakching Khunou Camp.

Hence, Khangembam Apui Meitei and Moirangthem Alex Meitei were arrested from the spot i.e., near Koirengei Kabui Khul Gate, Imphal East District at 02:31 pm and 02:38 pm respectively by observing necessary formalities.

From the possession of Khangembam Apui Meitei, one Redmi Note 10T 5G Pro mobile handset along with one Airtel SIM card bearing mobile no. 7896428931 (as disclosed by him) was seized from the spot at 02:45 pm by observing due formalities.

From the possession of Moirangthem Alex Meitei, one realme narzo 50i mobile handset along with two SIM cards i.e. (a) one Airtel SIM card bearing mobile no. 7085623067 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 9356822415 (as disclosed by him) was seized from the spot at 02:49 pm by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
