

Subject:- Report.

Sir,

With due respect, I am to state that today, i.e. 15th May, 2025 at about 11: 00 am received a reliable information from a reliable source that some contraband Drugs are kept concealed at the house of Md. Abdullah Khan (46) S/o Md. Atawallah Khan of Khabeisoi Sabal Leikai. The source report is reduced in writing however the search warrant and authorization from a Gazetted officer could not be obtained as there was high possibility of escaping of the offender along with the contraband drugs from the said place. So, after intimating to my senior officer, I along with a team of Special CDO team, khabeisoi rushed at the said house and on reaching at the said house, our CDO team detained the house owner namely Md. Abdullah Khan age (46) S/o Md. Atawalla Khan of Khabeisoi Sabal Leikai who were found inside his house.

At the spot, I have given option for search to him giving option to be search him in the presence of a Gazetted officer or magistrate or two independent witnesses in which the house owner, Md. Abdullah Khan has given his option to be search in the presence of 2(two) independent witnesses. So, I have requested two independent witnesses present at the spot to co-operate and witness in the formal procedure. The 2(two) Independent witnesses agreed on my requested and conducted his body search in which 6 (six) vile suspected to be contain contraband Drugs (heroine) are found present on the right side back pocket of his pant.

Accordingly, seized 6(six) Nos. of vials containing suspected contraband drug (heroine) from the possession of Md. Abdullah Khan by preparing a seizure memo in presence of 2(two) Independent witnesses at 06:24 pm. On preliminary interrogation at the spot, he admitted that he is selling the contraband drugs to the teenager and drug users to earn money for the past years. So, arrested him from the spot by preparing separate arrest memo at 06.32 am.

Subsequently, a report U/S 57 ND& PS Act for seizure of contraband Drugs and arrest of the accused person have been submitted to the Officer-in-Charge Special CDO Unit, Khabeisoi.

So, the arrested person along with the seized contraband drugs are handed over to you for taking further necessary legal action.
