Sir,

I have the honour to report that today i.e. the 21<sup>st</sup> May, 2025 at about 5:00 p.m. received a reliable information from ECIB (Eastern Command Intelligence Battalion) & 165 TA (Territorial Army) corroborated with our own intelligence about the presence of some active members of the outlawed outfit PREPAK at Koirengei Bazar Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops.) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 6:10 p.m.

As a part of the operation, random frisking and checking was conducted to the suspected passersby. In that, one suspected car was detained for checking and verification at the crossing of Koirengei bazar, Imphal East District. On checking the car and belongings of the detainee, one 9 mm Pistol, one wallet and mobile phone were found and recovered. On verification, the detainee identified himself as one **Nongthombam Robindro Singh @ Robin (52 years) S/o N. Rajmani Singh of Sekmai Koujeng Leima Mamang Leikai, Sekmai PS, Imphal West District**. On further verification, the detainee stated that he is an active member of the outfit PREPAK joined through one Mr. Romeo of PREPAK in the month May, 2023 and presently working under his command.

So, the detainee was arrested from the spot i.e. Koirengei Bazar, Imphal East at 7: 10 p.m. and seized; (i) **one 9 mm Pistol loaded with one live round in the magazine**, (ii) **one car (Maruti Alto) bearing regd. WB-2R/9812, silver in colour**, (iii) **one mobile phone (Oppo A5s) bearing IMEI no. 860591047737033 & 860591047737025 along with two SIM cards bearing mobile no. Airtel - +91 8132071670 and Jio - +91 9366220454** and (iv) **one wallet containing a sum of Rs. 6 640/- (six thousand six hundred forty rupees) and one AADHAR card from his possession at the spot i.e. spot i.e. Koirengei Bazar, Imphal East at 7:12 p.m. by observing due formalities.**

On further verification, it came to learnt that he kept conceal one sniper rifle and some ammunitions at an abandoned shop at Achanbigei Mayai Leikai, Imphal East District, which was handed over to him by the said Mr. Romeo of PREPAK. Immediately, our team along with the arrestee rushed to the said place and on the instance and pointing of the arrestee, one sniper rifle and four nos. of live ammunitions were found and recovered. The recovered; (i) **One 7.62 mm Sniper Rifle (ii) two nos. of 7.62 mm live ammunitions, (iii) two nos. of 9 mm live ammunitions,** were seized from the spot i.e. Achanbigei Mayai Leikai, Imphal East District at 7:25 p.m. by observing due formalities.

Therefore, the arrested person along with seized arms, ammunitions, car and mobile phone etc. is being handed over to you for taking up further necessary legal actions against him.
