Subject: Report.



Sir,

I am to report that today i.e. 03/09/2025 at around 1.00 pm, received a reliable input from 19 Garhwal Rifles corroborated with our own source regarding about the movement of some miscreants at Basikhong area who was involved in extortion from general public, local businessmen, school, college etc. in Bishnupur District. Immediately, based on the input, a joint team of CDO-BPR led by self and assisted by HC O. Jayenta Singh and Civil teams of CDO-BPR under the command of Inspt. Y. Motilal Singh, OC-CDO/BPR under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops) Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur rushed to the said area and conducted search of the suspected persons at Basikhong Lai Lampak area after giving prior information to the concern authority.

During the course of search, one suspected person was seen driving one Activa purple in colour on suspicious manner. So he was detained on the spot for verification. On thorough verification, he identified himself as Kangujam Nongmaikhomba Meitei @ (50) S/o (L) K. Hera Meitei of Basikhong. He was an active member of People's Liberation of Army (PLA) presently working under the command of one Mangang of the banned organization People's Liberation of Army (PLA). On further questioning, he revealed that, he threatened to the construction contractors of Educational Institutions in Bishnupur District and demand 40% from the construction fund to their party. Accordingly, he was arrested from the spot at 2.37 pm near Basikhong Lai Lampak. On body search, found i) one Nokia C01+ mobile phone black in colour with two SIM card having mobile no. i) airtel (9862154023) and ii) BSNL(9402959600) and one Activa purple in colour bearing registration no. MN01C 3338 were recovered and seized from his possession at 2.43 pm at the same spot by observing proper formalities.

Hence, the arrested person along with the seized items were handed over to you for taking further necessary legal action against him.
