Subject: - Report.

Sir,

I have the honour to state that today i.e. 07/09/2025 at around 02:35 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP organization, an outlawed banned organization in and around Khongmang Bashikhong area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information and with the permission/authorization of the authority, a team of CDO-IW led by Inspector Anilchandra Mutum of CDO-IW assisted by Subedar L. Bikramjit Singh of CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Bashikhong Mamang Leikai area. During that one suspected person was detained at a house located at Bashikhong Mamang Leikai area. During spot verification, the detainee identified himself as Laishram Timtim Singh (25 yrs.) @ Krishnakanta S/o. (L) L. Suresh Singh of Bashikhong Mamang Leikai, Wangkhei Loumanbi, Imphal East District, Manipur (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active member of KCP (PSC) organization (a faction of KCP organization) led by one s/s Chairman Ibungo Ngangom and joined the said organization in the year 2023 through one Roshan of KCP (PSC) organization from Mayanglangjing area and got Basic Military Training for 15 days at Koutruk area and was allotted Army No. 222T. He also disclosed that he worked under the command of one s/s Commander Leishemba @ Pari of KCP (PSC) organization from Lamdeng area. He further disclosed that under the instruction of his commander, he was involved in selling of a Bolero car white in colour (which was illegally possessed and used by them in their party activities) to a vehicle scrapping place located at Wangkhei area around 2 months back and got Rs. 50,000/-, as a proceeds of sale of the said Bolero car, which was later handed over to his commander as their party fund.

Hence, he was arrested from the spot i.e., from his residence at 03:42 pm by observing necessary formalities.

From his possession, (i) one iPhone XR mobile handset along with one Jio SIM card bearing mobile no. 7005279417 (as disclosed by him) and (ii) one Aadhaar card bearing no. 6381 9696 7745 were seized at the spot at 03:49 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
