Sir,

I am to state that acting on a specific information, a combined team of Imphal East District Police and 86 Bn. CRPF under the command of Shri Ak. Sadananda Singh, Addl. SP., Traffic-Nodal Officer Anti-Narcotics Task Force (ANTF) and Shri Yumnam Joyraj Singh, Addl. SP., Ops, Imphal East District, conducted a raid at Keirao Toukhok Loukon, on 08/09/2025 at about 02:00 am, in presence of an Executive Magistrate. In that, a makeshift bottling hut suspected to be of bottling opioid codeine was busted with the recovery and seizure of the following items at 02:20 am:

1. One bottling iron machine,
2. Three numbers of blue colour plastic can mark as "A"-weighing 10.930 Kg, "B" weighing 37.910 Kg, and "C" weighing 38.550 Kg, all containing suspected opioid codeine,
3. 1461 (one thousand four hundred and sixty-one) numbers of brown colour empty bottles,
4. 625 (six hundred and twenty-five) numbers of white colour plastic caps,
5. Two packets of white colour lids,
6. One white colour mosquito net, a pair of camouflaged combat dress and a red colour embroidered shawl, and
7. 185 (one hundred and eighty-five) numbers of filled plastic bottles containing suspected Opioid Codeine.

It is pertinent to mention that no person was found present at the said location at the time of operation and hence no arrest could be effected. The temporary makeshift used for carrying out the illegal activities was demolished to prevent further use.

The seized items are, therefore, handed over to you for taking further necessary actions.
