3. Conduct-
 - (a) On the specific int of cache of wpns and WLS being hidden in Gen A P Thumpajoi (4 km E of TOB chamol Top) two Op colns of str 01-01-15 (Ex COB Salluk and COB Aigejang) were launched.
 - (b) The OP Colns as per specific int cordoned the area at around 0600h and the cordoned the area at around 0700h. The area was searched intensively with digging tools and at around 0725h cache of wpns and WLS were found by the OP colns.
