FIRST INFORMATION REPORT

1. Based on intercept received from 36 LIC EW det at Rana Top at 2100 h regarding likely presence of hidden cache of drugs ('Saman') in General Area T jangmuom (06 km East of COB Rana Top & 08 km North of IMB, Along kanalok River) a search ops was launched wef 2230hrs on 17 Sep, 2025.
2. During the course of the search at around 0530hrs, The columns recovered few sacks with suspected Opium & Alkaloid (suspected residue after extracting from raw opium) hidden in the area.
3. Details of Recovered
  - (a). Suspected Opium containing in two sacks and after weighing it is about 57.35 kgs
  - (b). Alkaloid (suspected residue after extracting from raw opium) containing in 1(one) sack and after weighing it is about 49.920 kgs, total value approx. Rs 5. 26 crores @ Rs 5 lakh)
4. The recovered items are being handed over to CKG-PS for further investigation.
