I have the honour to submit you the report that on 17th Sept 2025, based on the Specific Input received from own source regarding likely presence of WLS in gen area of Rd Nala Jn (SQ 7303) near vill Zoldam (Notified Area). An Op was launched by a coln of str of 01-01-40 ex COB Gamphazol wef 2130 hrs on 17th Sept 2025 to search the area. The Search party was divided into two groups to thoroughly search the thickly vegetated area. After extensive search of the area, at around 0630 hrs on 18th Sept 2025 one of the parties found a suspicious patch and on carrying detailed search, a hidden cache containing WLS was unearthed at GR 734033. The op was continued to check for presence of similar caches in the suspected area. After thorough search of the area and no further recovery, the ops was terminated at 0800 hrs on 18th Sept 2025.
