15. Date and time of dispatch to the Court:

Today, i.e., 16/07/2025 at 11:40 am, received an information that a Road Traffic Accident occurred at around 11:30 am, a vehicle (Swift Dzire) black in colour bearing Regd. No. MN01W-2308 which was come from Imphal towards Koirengei side lost control and hit two unknown persons at Mantripukhri opposite DSLF Oil pump along NH-2. Consequently, one of the two unknown person was succumbed at the spot due to severe injuries and another unknown person sustained injuries and was immediately evacuated to hospital for medical treatment. Following the initial collision, the said Swift Dzire further hit a vehicle A-star grey in colour bearing Regd. No. MN07D-0691 simultaneously. The two vehicle which were involved in the incident were badly damaged.

Hence, a suo-motu case has been registered under FIR No. 63(07)2025 HNG-PS u/s 281/125(b)/324(4)/106 BNS for investigation.
