Subject : Report.

Sir,

I have the honour to report that today i.e. the 16th July, 2025 at about 6:00 p.m. received a reliable information from our own intelligence about the presence of some anti-social elements at Koirengei area of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE conducted a searched operation at Koirengei and its surrounding area of Imphal East District at about 7:10 p.m.

In that, one suspicious unknown person was detained for spot verification and checking at Koirengei-Awang Potshangbam Road near Keikol Police Post, Imphal East District. On checking the detainee body, one mobile phone and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one **Sorokhalbam Parl Singh @ Ibungo (26 years) S/o S. Abung Singh of Senjam Chirang Mayai Leikai, Sekmai PS, Imphal West District**. On further verification, the detainee stated that he is an active member of the outfit NRFM joined through one Mr. Nanao of NRFM in month of February, 2024 and presently working under the command of one Mr. Premananda of NRFM. The detainee further stated that, on the advice of the said Mr. Premananda of NRFM, he had transported arms & ammunitions, cadres/members of their outfit from place to place and he was directly involved in kidnapping of peoples from various places for taking ransom money to raise their party fund.

So, the detainee was arrested from the spot i.e. Koirengei-Awang Potshangbam Road near Keikol Police Post, Imphal East District at 7:43 p.m. by observing due formalities. From the possession of the arrestee; **(i) One mobile phone (Iphone 11 pro) bearing IMEI no. 353838105100636 & 353838105147728 along with one Jio SIM Card bearing no. 9366292511 and (ii) one wallet containing a sum of Rs. 1000/- (one thousand rupees) and one AADHAR card** were seized at the spot i.e. Koirengei-Awang Potshangbam Road near Keikol Police Post, Imphal East District at 7:50 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
