

Sir,

I have the honour to report that today i.e. the 19th July, 2025 at about 10:00 a.m. received a reliable information from our own source corroborated with the intelligence of 4 AR about the presence of some anti-social elements at Kontha Ahallup and its surrounding area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 4 AR, under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE conducted a searched operation at the said area at about 11:00 a.m.

In that, one suspicious unknown person was detained for spot verification at his residence at Kontha Ahallup Makha Leikai, Imphal East District. On verification, the detainee identified himself as one Konjengbam Tomba Singh @ Laingam (38 years) S/o K. Tomei Singh of Kontha Ahallup Makha Leikai, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit PREPAK joined through one Mr. Naotombi @ Khelemba of PREPAK in the year 2011 and got-his basic military training for two months under the command of one s/s – Sergeant Major Mr. Japan of PREPAK at Tanal, Myanmar with allotted army no. 38027 of 38th batched. The detainee further stated that presently he is holding the rank of s/s – Sergeant Major and working under the command of one s/s Lieutenant Colonel Mr. Chamba of PREPAK. The detainee further stated that on the advice of the said Mr. Chamba of PREPAK, he had recruited one person to their outfit in the month of October, 2024.

So, the detainee was arrested from his residence i.e. Kontha Ahallup Makha Leikai, Imphal East District at 11:36 a.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
