Subject :- Report.

Sir,

I have the honour to report that today i.e. 21/07/2025 at about 02:00 p.m. received a reliable information from D-Coy 66 Bn. CRPF by SAFE/TBL (special action force for extortion) that some active cadres of UPPK, a banned unlawful organisation were loitering in and around Koirengei Chingol area for prejudicial activities like extortion. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police Thoubal District and 2 (two) sections of D-Coy 66 Bn. CRPF immediately rushed to Koirengei Chingol Leikai area at around 02:45 p.m. after giving necessary information to Control Room, Imphal East District. In that 1 (one) Hyundai Getz bright silver in colour was intercepted. On suspicion, the car was detained for verification.

On preliminary verification, the driver and the occupants were identified themselves as 1) Nishan Ngangbam @ Tamngakpa 24 yrs. S/o. Ng. Sarat Meitei of Khumbong Mayai Leikai, Imphal West District, 2) Laishangbam Roshan Singh @ Yaibi 35 yrs. S/o. L. Ibocha Singh of Churachandpur Khuga Tampak Meitei Leikai, a/p Langol Game Village, Zone-I, Imphal West District, 3) Chungkham Kiran Meitei @ Lepsinba 21 yrs, S/o. Ch. Amusing Meitei of Khumbong Mayai Leikai, Imphal West District and 4) Chandam Ratan Meitei @ Lion 41 yrs. S/o. (L) Ch. Rajo Meitei of Koirengei Bazar, Imphal East District an active cadres of banned UPPK unlawful organisation.

On further verification Nishan Ngangbam @ Tamngakpa 24 yrs. S/o. Ng. Sarat Meitei disclosed that he joined UPPK on the month of October, 2024 through one S/s 2<sup>nd</sup> Lieutenant Cheinangakpa @ Moirancha of their Organisation. He got 3 (three) months basic military training at Kakching Khunou. He further disclosed that he was arrested by CDO/IW on 9<sup>th</sup> March, 2025 after released on bail he again re-join UPPK. Laishangbam Roshan Singh @ Yaibi disclosed that he joined UPPK in the year 2010, he got 3(three) months basic military training at Eastern Nagaland, Myanmar and he was promoted to the rank of 2<sup>nd</sup> Lieutenant, Chungkham Kiran Meitei @ Lepsinba disclosed that he join UPPK in the year 2024 through one Cheinangakpa @ Moirancha of their Organisation. He further disclosed that he was arrested by CDO/IE on 14<sup>th</sup> May, 2025 after released on bail he also re-join UPPK. Chandam Ratan Meitei @ Lion disclosed that he joined UPPK in the month of October, 2024 and he got the rank of Tribunal team commander of UPPK.

On their bodies search 1(one) mobile iphone XR with 1 (one) Airtel SIM card bearing mobile No. 8132872402, 1 (one) money purse, 1(one) Aadhaar card bearing No. 2380 9766 2905 were detected from the possession of Nishan Ngangbam @ Tamngakpa, 1(one) Redmi mobile handset with 1(one) Airtel SIM card bearing mobile No. 8132050105, 1(one) Aadhaar card bearing No. 6425 6037 1477, 1(one) money purse, 1(one) Nepalese currency of Rs. 10/-, a sum of Rs. 9230/- (nine thousand two hundred and thirty) only of different denomination (500×18, 100×2, 20×1 and 10×1) were detected from the possession of Laishangbam Roshan Singh @ Yaibi, 1(one) Redmi mobile handset with 1(one) Jio SIM card bearing mobile No. 9366534583, 1(one) Aadhaar card bearing No. 8052 8229 8464, 1(one) PAN card bearing No. IBQPM8352E, 1(one) money purse were detected from the possession of Chungkham Kiran Meitei @ Lepsinba and 1(one) Samsung mobile handset with 1(one) Airtel SIM card bearing mobile No. 8729862899, 1(one) Realme mobile handset with Airtel SIM card bearing mobile No. 8414811210, 1(one) Aadhaar card bearing No. 6694 9172 8831 and 1(one) money Purse were detected from the possession of Chandam Ratan Meitei @ Lion.

Further they disclosed that they were involved in extortion activities by serving monetary demands and threats etc. in the valley Districts under the instruction of S/S 2<sup>nd</sup> Lieutenant Moirangcha @ Cheinangakpa of their organisation UPPK.

Hence, they were arrested at 03:20 p.m., 03:21 p.m., 03:22 p.m. and 03:23 p.m. respectively of 21/07/2025 from Koirengei Chingol near stone crusher by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some members of the above said unlawful organisation may attack or some organised public mob may be initiated to forcefully free the arrested accused persons.

The arrested persons mentioned above along with the seized items are handed over to you for taking further necessary legal action against them.
