**Subject : Report.**

Sir,

I have the honour to report that today i.e. the 25<sup>th</sup> July, 2025 at about 8:00 p.m. received a credible information from our own intelligence corroborated with the intelligence of 165 TA about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Pangei Ching, Nepali Basti and its adjoining foothill areas of Imphal East District. Based on the said information a combined team of CDO/IE Unit, 4 AR, and a column of Ex 165 TA along with a team of Heingang PS, under the command of Inspt. N. Devdas Singh, Officer-in-Charge Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops) Imphal-East District rushed to the said area and conducted a searched operation at 9:00 p.m.

During the search operation, the undernoted arms, ammunitions, explosives and others items were found hidden in a bush at the foothill of Pangei Ching, Nepali Basti, Imphal East District.
