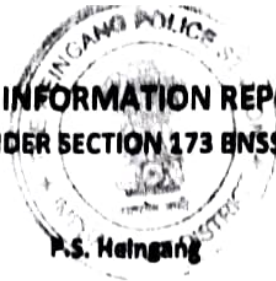

Subject : Report.

Sir,

I have the honour to report that today i.e. the 28th July, 2025 at about 4:00 p.m. received a credible information from our own source corroborated with the intelligence of ECIB (Eastern Command Intelligence Battalion) and 10 Bn. BSF, about the presence of some anti social element likely to carried out pre-judicial activities at Kairang Village, Imphal East District. Based on the said information, a combined team of CDO/IE Unit, 2/8 GR, 10 BSF and 4 AR conducted a C. I. Ops. at Kairang Village, Imphal East District under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at about 5:00 p.m.

In that, one suspicious unknown person was detained for spot verification at Kairang Umang Mayai Leikai, near Primary School, Imphal-East District. On checking the detainee body, one .32 Pistol, one magazine, three nos. of ammunitions and one mobile phone were found and recovered from his possession. On verification, the detainee identified himself as **Md. Samir Khan @ Inao (45 years) S/o (Late) Md. Aslam Khan of Kairang Umang Mayai Leikai, Heingang PS, Imphal East District.** On further verification, the detainee stated that he is a member of the Gang group '*Ningolmacha*'. He further stated that the above recovered arms and ammunitions were handed over to him by one Mr. Arun about three months before.

So, the detainee was arrested from the spot i.e. Kairang Umang Mayai Leikai, near Primary School, Imphal East District at 5:25 p.m. and seized: *(i) one .32 Pistol without magazine, (ii) one 9 mm Pistol magazine, (iii) 1 (one) nos. of .32 ammunitions, (iv) 2 (two) nos. of 9 mm ammunitions and (v) one mobile phone (Redmi 10 prime) bearing IMEI NO. 868480056609916/01 & 868480056609924/01 along with one Airtel SIM card having phone No. 7005349223* from his possession at the spot i.e. Kairang Umang Mayai Leikai, near Primary School, Imphal East District at 5:35 p.m. by observing due formalities.

Therefore, the arrested person along with the seized item are being handed over to you for taking up further necessary legal actions against him.
