Subject:- Lodging FIRST INFORMATION REPORT regarding the theft that occurred at the building of Software Technology Parks of India(STPI), under MeitY, Govt. of India, at Mantripukhri, Imphal

Sir,

With due regards, I, the undersigned would like to state the following information for your kind knowledge and necessary action.

1. That, STPI is having its old building situated at Mantripukhri, Imphal. The said building was damaged by an earthquake beyond repair. As such, STPI had shifted its office to MIMS building at Manipur University campus since March 2023.
2. That, on 3rd August 2025, one Security staff namely Laishram Jiten, had gone to the old building for regular inspection and found that the lock of the Network room on the 1st floor of the office was broken and certain items were stolen.
3. On coming to know about the said incident, we went to the old building of STPI to assess the missing items and verified that the following items were stolen:
 7. Quanta Battery 40AH for UPS(a set of 20 +1)
 8. 3 old desktops and 1 laptop (obsolete/faulty)
 9. 2 Water Pumps
 10. 10 Ceiling Fans (obsolete/faulty)
 11. Wirings on the walls (including copper earthing wires)
 12. 4 sub-distribution Electrical panels.
