12. First Information contents: The brief of the case is that, on the 30<sup>th</sup> August, 2025 received a reliable input from reliable source that a consignment of illegal drug will be transported along Guite Road on NH-102B. Acting on the input from source, a team led by OC/SGT-PS and 36 Assam Rifles led by Major Akshay, of 36 Assam Rifles, CCPur under the supervision of SDPO/CCP and under the overall supervision of SP/CCP immediately setup Temporary Motor Vehicle Check Post (TMVCP) on NH-102B around 3 kms West from Singngat Police Station at 5:25 p.m. Every vehicle plying to and fro were frisked and thoroughly checked. But no seizure of the said illegal drugs or arrest was made.

In the meantime, a recce team of 4 personnel in civvies led by SI Chinzasiam who were moving towards Maukot Village came across one Kenbo bike in a very suspicious manner. The team immediately turned around and pursue the vehicle. The said Kenbo bike was found abandoned beside the road between the TMVCP and the recce party. When the team got down to inspect the bike, two unknown persons who were hiding behind the bushes in the dark started running down the thick jungle clip taking advantage of the dark. The team immediately informed the TMVCP at around 9:19 p.m. who rushed to the location. The suspected unknown persons were pursued by the combined team and thorough search of the area was conducted. However, no arrest was made and the search lasted till 2:11 a.m. of 31-08-2025. The abandoned Kenbo Bike was taken to Singngat Police Station.

Again, on 31-08-2025 a recce was sent to the spot at around 9:00 a.m. where the suspected accused fled. The recce reported that one Mahindra Bolero was parked at the location. Immediately, the check gate at Singngat was alerted. At around 9:45 a.m. the Bolero approached the check gate and was stopped. On checking the vehicle one of the occupants with injured ankle was found in a suspicious manner. The Bolero belongs to the son-in-law who came to pick up the injured suspected accused. On spot interrogation it is learnt that he was one of the person whom the combined team had pursued the previous night and was taken to the police station for interrogation. On

interrogation he disclosed that, he had hidden the soap cases in the bushes near Ebenezer Oil Pump, Singngat.

Meanwhile police teams in civies and uniform made search for the other accused person in and around Singngat. While OC/SGT-PS and his escort party were moving towards SDO Complex at around 11:08 a.m. came across on person in a shabby and muddy dress on foot. On suspicion he was interrogated and he revealed that he was the other suspected accused that fled last night. He was immediately picked up and taken to the Police station for further interrogation. On interrogation he revealed that he had hidden the drug consignment i.e. suspected Brown Sugar beside the road where they had fled last night.

Executive Magistrate, Singngat Sub-Division, Churachandpur District was immediately requisition for the recovery and seizure of the suspected brown sugar. On arrival of the Executive Magistrate, at 2:20 p.m. the joint team of police personnel and Assam Rifles along with Executive Magistrate and the two accused rushed to the spots and recovered and seized the suspected brown sugar from two different locations following all SOPs.

Hence, a Suo-Moto case under FIR No.06(08)2025 u/s 21(C)/60(3)/29 of ND & PS Act is registered for further investigation.
