

Sir,



I have the honour to report that today i.e. 24/08/2025 at about 04:00 pm received a reliable information that Md. Naseer Khan 36 yrs. s/o. Md. Majid Ali of Sangaiyumpaham Part-I, Sabal Leikai is kept concealed some stolen two wheeler vehicles at his residence. On receiving the above information, the combined teams of CDO, Thoubal led by Shri K. Nitranjan Singh, OC/CDO, Thoubal under the supervision of Shri H. Devendra Singh, Addl. SP(Ops), Thoubal and under the overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police, Thoubal District rushed to the spot. On reaching the residence of Md. Naseer Khan 36 yrs. s/o. Md. Majid Ali of Sangaiyumpaham Part-I, Sabal Leikai, one unknown person was seen running towards the paddy field in a suspicious manner. The combined teams immediately chased and overpowered the unknown person and detained for verification.

On spot verification, the unknown person identified himself as Md. Naseer Khan 36 yrs. s/o. Md. Majid Ali of Sangaiyumpaham Part-I, Sabal Leikai. On his body searched i) one Redmi note 9 pro along with 2 (two) SIM cards i.e. Jio mobile No. 8787534864 & Airtel mobile No. 9378009229, ii) one Aadhaar card No. 6498 6977 0944, one voter ID card No. KCV016262 and iii) one PAN card No. KBBPK8856A were detected from his possession. He further, revealed that he had kept concealed one stolen Yamaha fascino blue in colour at his house. Immediately, the combined teams rushed to his house and found one Yamaha fascino blue in colour without Regd. No. which was kept concealed behing his house and one Maruti Suzuki Astar Vxi white in colour without Regd. No. which was parked at his courtyard. Further he disclosed that he and his associate Md. Amar 33 yrs. s/o (Late) Md. Tulhid of Sangaiyumpham Mairenkhun had used the said Maruti Suzuki Astar Vxi white in colour without Regd. No. while going for lifting various vehicles.

Hence, he was arrested at 04:40 pm of 24/08/2025 from his house at Sangaiyumpham Part-I, Sabal Leikai and seized the above mentioned i) Maruti Suzuki Astar Vxi white in colour without Regd. No., ii) Yamaha fascino blue in colour without Regd. No. iii) Redmi note 9 pro along with 2 (two) SIM cards i.e. Jio mobile No. 8787534864 & Airtel mobile No. 9378009229, iv) one Aadhaar card No. 6498 6977 0944, v) one voter ID card No. KCV016262 and vi) one PAN card No. KBBPK8856A at 05:05 pm from his possession by observing necessary formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as some public organized a mob to obstruct the seizure of the above vehicle & to set free the accused person.

Hence, the arrested person mentioned above along with the seized articles are being handed over to you for taking further necessary action.
