Subject: Formal Complaint letter against employee Ranjan Oinam for Theft and Misappropriation of Funds

Dear Sir/Madam,

Lam writing on behalf of CMS info systems Limited, a cash management services provider operating across various locations including Imphal, Manipur.

I would like to formally complaint against Mr. Ranjan Oinam who was working as ATM cash replenishment custodian in Imphal, Maipur.

The first issue was reported on 22nd July 2025 by our ATM custodian Leichonbam Niraj Singh and Chingakham Jaiviyas, during cash loading and evacuation of CRM Machine DPRH452201 at our Opposite Thoubal Municipality location. They reported a shortage of 50,000 in the machine.

Upon receiving the statement, we instructed both CRAs to verify the matter and coordinate with the bank to check CCTV footage of the previous cash loading. On 23rd July, after reviewing the footage, it was observed that CRA Ranjan Oinam was seen taking the missing amount and placing it in his personal bag on dated 19the July, 2025, confirming an act of theft.

After our investigation team visiting the Imphal location he admitted that he took the money from ATM via what's app mossage and written letter and he gave 50 thousand amounts.

In light of the above, I have shared a formal complaint letter against Ranjan Oinam.
