He further demanded to see the vehicle documents and asked me to show my identity card for his verification. He also told me that "I am a sepoy of NSCN" and doing duty for organisation.

I politely informed him that we were police officers proceeding to Imphal on duty. Despite this, he ordered our driver to get down from the vehicle and demanded Rs. 2000/- as "entry fees." for their organisation. When my driver refused, stating that we did not have such an amount, the youth came to my side and again instructed me to produce my identity card. He also took photographs and recorded a video of me without my permission and our Government vehicle.
