Today ie 04/09/2025 at around 1330 hrs, received a reliable input about the presence of member of banned organization PREPAK(PRO) at Chairel Khunjao area. A combined team of CDO-Unit Kakching led by HC M Bobo and Hav N Chaoba along with a team of COB, Waikhong, 46 AR led by AC Tripati Nath Trivedi under the supervision of Smt Priyadarshini Laishram, SP, Kakching rushed to the area to conduct a search operation at suspected areas. During the search, the team detained one suspected individual matching with the input at a paddy field along Pangaltabi-Chairel Khunjao Louyai IVR.

On verification, the individual was identified as one Laishram Thoithoi @Lanthouba (23) s/o L Mohen Singh of Chairen Mangjing, Bishnupur Dist. The detained individual disclosed that he is an active cadre of the banned organization PREPAK(PRO). He joined the organization in December 2023 through one s/s Capt Nonocha of the banned organization PREPAK(PRO) and presently working under the command of one s/s Lt Lashram Bhumeswar @ Ingba of Chairen Mangjing Bazar near community hall. It was also revealed that as directed by Laishram Bhumeswar, he had made extortion demands from general public in Pangaltabi and wangoo area and that one black activa was given by
