I have the honour to report that today i.e. the 17th May, 2025 at about 11:00 a.m. received a reliable information about the presence of one active member of the outlawed outfit KYKL at Khabeisoi area of Imphal-East District. Based on the said information, a combined team of CDO/IE Unit & 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 12:00 noon at Khabeisoi, Imphal-East District.

In that, one suspicious unknown person was detained for spot verification at Khabeisoi near 7 MR Gate, Imphal-East District. On verification, the detainee identified himself as one **Ningthoujam Romen Singh @ Nanao (35) S/o (Late) N. Nandakeshwore Singh of Pangaltabi Makha Leikai, Wangoo Police Station, Kakching District.** On further verification, the detainee stated that he is an active member of the outfit KYKL joined through one S/s – Sergeant Major Mr. Bocha of KYKL in the month of June, 2023 and presently working under his command. The detainee further stated that, on the advice of the said Mr. Bocha of KYKL, he was involved in recruiting new cadres to their outfit.

So, the detainee was arrested from the spot i.e. Khabeisoi near 7 MR Gate, Imphal-East District, at 12:35 p.m. by observing due formalities and seized one mobile phone (Redmi 12 5G) bearing IMEI no. 868350066796723 & 868350066796731 along with two SIM cards bearing mobile nos. Jio – 7005963409 & Airtel – 9378071068 from his possession at the spot i.e. Khabeisoi near 7 MR Gate, Imphal-East District at 12:40 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
