Today i.e. 17/05/2025 at 08:40 pm, received an information that on the same day at around 08:30 pm, Honda Dio bearing registration No. MN01AF-7651 which was coming from Imphal towards Lamlai side collided with one Tata ACE bearing registration No. AS02CC5510 coming from opposite direction at Khabeisoi in front of Oil Pump along the Imphal Ukhrul road. As a result, driver and pillion rider of the Honda Dio sustained injuries on their body and were evacuated to Hospital for medical treatment whereas both the vehicles were severely damaged.
