Subject : Report.

Sir,

I have the honour to report that today i.e. the 21st May, 2025 at about 4:00 p.m. received a reliable information about the presence of some active members of the outlawed outfit KCP at Kairang area of Imphal East District. Based on the said information, a combined team of CDO/IE and 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 4:50 p.m.

In that, two suspected persons coming in a scooter were detained for spot verification and checking at Kairang Mamang Leikai, Imphal East District. On checking their bodies, two nos. of mobile phones were found and recovered. On verification the driver of the scooter, he identified himself as one **Chingangbam Bidhyananda Singh @ Tomba (26 years) S/o (Late) Ch. Ito Singh of Taothong Mayai Leikai, Imphal West District.** On verification of the pillion rider, the detainee identified himself as one **Thangjam Diya Singh @ Manimatum (24 years) S/o Th. Gokulchandra Singh of Lamshang Makha Leikai, Imphal West District.**

On further verification, both the detainees stated that they are active members of the outfit KCP (MFL) group joined through one Mr. Joy of KCP (MFL) group in the month of January, 2025 and presently under his command. They further stated that today on the advice of the said Mr. Joy they came to Kairang to met one Mr. Leishemba of KCP (MFL) group to make a deal for selling five nos. of Hand Grenades at the cost of Rs. 7, 000/- (seven thousand rupees) for each hand grenades, with a total cost of Rs. 35, 000/- (thirty five thousands rupees).

So, both the detainees were arrested from the spot i.e. Kairang Chingya Mamang Leikai, Imphal East at 5:15 p.m. and sized **one scooter (Honda Dio), carbon black in colour, bearing regd. no. KA 01JF/5235 bearing Engine no. JF39EG0036050 and Chassis no. ME4JF39KFKG014600 and one mobile phone (Oneplus Nord CE2) bearing IMEI no. 869590068588714 & 869590068588706 along with one Airtel SIM card bearing mobile no. +91 8974086005** from the possession of the arrestee Chingangbam Bidhyananda Singh at the spot i.e. i.e. Kairang Chingya Mamang Leikai, Imphal East at 5:20 p.m. by observing due formalities.
