**Subject: Report.**

Sir,

I have the honour to report that today i.e. the 23<sup>rd</sup> May, 2025 at about 4:00 p.m. received an information from FGT (Field General Team) Imphal, BSF corroborated with our own intelligence about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Pangei Nepali Basti and its surrounding area of Imphal East District. Based on the said information, a combined team of CDO, Imphal-East District and 164 Bn. BSF under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal East District rushed to the said area and conducted a searched operation in the general area of Pangei Nepali Basti and its adjoining foothill areas of Imphal East District at about 5:00 p.m.

During the search operation, found one white sack bag suspected to be containing arms, ammunitions and explosives hidden in a bush at the foot hill of Pangei Nepali Basti Imphal East District. On opening the white sack bag the undernoted arms, ammunitions and explosives were found and recovered;

2. 1(one) 9 mm Pistol with magazine,
3. 3(three) nos. of No. 36 hand grenade with two nos. of arming ring,

6. 5(five) nos. of 5.56X45 mm live ammunition,
7. 10(ten) nos. of 5.56X30 mm live ammunition,
8. 5 (five) nos. of 7.62X51 mm live ammunition,

10. 5(five) nos. of .303 live blank cartridge,
11. 6(six) nos. of 9 mm live ammunition,

Accordingly, the above recovered arms, ammunitions, explosives along with the one sack bag were seized at the spot i.e. foothill of Pangei Nepali Basti Imphal East District at 5:27 p.m. by observing due formalities.

Thereafter, the seized items are being handed over to you for taking up further necessary legal procedures.
