

Sir,

We, the undersigned residing from Sangaikot Sub- Division, Churachandpur are writing to request the filing of a first information report(FIR) against MR. Ashang Kasar, Self-style Social Activist, under relevant sections of the BNS, who has been making inflammatory and derogatory comments on (Social Media platform – called on X). His comments are likely to flare up communal tensions between two tribal communities and have the potential to disrupt peace and harmony in the region.

The content of his comments posted las Kasar Ashang (@ Ashang Kashar) on X is reflected as

"If anybody disturb Naga people's in Manipur , those who are staying in Kamjong, Tamei, Ukhurl District and Kangpokpi they will not stay in 2 second.... Remember Kuki Refugee people's in Manipur Meitei kill 200+ Kuki is nothing for Naga people's, remember 1993 @ meiteiheritage"

In addition, the accused (Ashang Kashar) has a history of making divisive and inflammatory comments in various TV discussion and public Forums, which has contributed to a toxic environment and promoted negativity among different communities. Therefore, his comments and behaviour have the potential to damage the social fabric of our country and undermine the unity and integrity of our nation.
