Subject: Report.

I have the honour to state that today, i.e. 30/04/2025 at about 01:30 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33-AR regarding the presence of some active cadres of RPF/PLA organisation in and around Khurai, Porompat area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a team of CDO IW led by Inspector Gunachandra Chanam, OC CDO IW and myself assisted by a team of CDO-IE under the command of Shri. P. Achouba Meitei, MPS, Dy.SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Khurai, Porompat area. During that, one unknown person was found in a Hyundai Santro car light grey in colour bearing Reistration No. MN1K 2572 which was found at NE-1 ground, Khurai, Porompat and he was detained at the spot for verification and checking.

On spot verification, he identified himself as Somorjit Thokchom (31 yrs.) a Loya s/o. Th. Sanajaoba Meitei of Ingourok Awang Ukikai, Thoubal District.

On spot checking, the following articles were recovered from his possession/at his instance:

(i) one Infinix NOTE 40X 5G mobile handset along with two SIM cards i.e., (a) Airtel SIM card bearing mobile no. 8118939303 (as disclosed by him) and (b) Jio SIM card bearing mobile no. 6009195521 (as disclosed by him), (ii) one Samsung Galaxy M12 mobile handset along with two Airtel SIM cards bearing mobile nos. 8416016385 and 9233963740 (as disclosed by him), (iii) one Aadhaar card bearing no. 4171 4426 6354, (iv) one brown side bag containing a sum of Rs. 43,800/- (rupees forty three thousand and eight hundred only) and (v) one Hyundai Santro car light grey in colour bearing Registration No. MN1K 2572 along with its registration certificate and keys.

During preliminary verification, he disclosed that he is an active member of RPF/PLA organisation and started working for the said organisation under one s/s Commander Melei (Deputy Finance Secretary) (WhatsApp No. 7629926301) of RPF/PLA organisation from Yairipok side since January/February, 2024 and he is presently working under the command of the said s/s Commander Melei and under the instruction of the said s/s Commander Melei, he is involved in extortion activities by serving monetary demands/threats and by collecting money from schools and general public etc. located in valley areas and the extorted money were handed over to his commander as their party fund. Further, he disclosed that today i.e., 30/04/2025, under the instruction of his commander, he collected the above recovered amount of extorted money i.e., Rs. 43,800/- from two schools located at Khewa, Tinsid road and Yairipok area by using the above mentioned Hyundai Santro car.

Hence, he was arrested from the spot at 03:30 pm and the above recovered articles were seized at the spot at 03:39 pm by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
