During preliminary verification, he disclosed that he is an active member of RPF/PLA organisation and started working for the said organisation under one s/s Commander Melei (Deputy Finance Secretary) (WhatsApp No. 7629926301) of RPF/PLA organisation ander the instruction of the said s/s Commander Melei, he is involved in extortion activities by serving monetary demands/threats and by animander as their party fund. Further, he disclosed that today i.e., 30/04/2025, under the instruction of his commander, he collected shove recovered amount of extorted money i.e., Rs. 43,800/- from two schools located at Khewa, Tioxid road and Vairipok area by the new temperature of the said s/s Commander as the collected shove mentioned Hyundai Santro car.

Hence, he was arrested from the spot at 03:30 pm and the above recovered articles were seized at the spot at 03:39 pm by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.


