I, Islaouddin Chaodhury, Principal of Princeton International School, am writing to formally report a serious and alarming incident that occurred today at our school main gate.

At approximately 5:00 am today, 04-05-2025, a hand grenade was found near the main gate of our school premises. Upon visual inspection, we deemed it potentially dangerous and immediately evacuated the area to ensure safety of our students and staffs. Shortly after the Bomb Squad arrived, they successfully removed the object and confirmed it was an explosive device.
