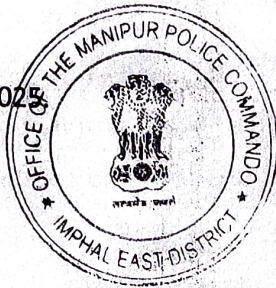

I have the honour to report that today i.e. the 11th May, 2025 at about 7:00 p.m. received a reliable information about presence of one active member of the outlawed outfit PREPAK at the general area of Porompat, Imphal-East District. Based on the said information, teams of of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at Porompat, along DC Road, Imphal-East District at about 8:00 p.m.

In that, one suspicious unknown person was detained for spot verification at Porompat DC Road near Water Supply Complex, Imphal-East District. On checking his body and belongings found one backpack containing; (i) 9 (nine) nos. of Demand Letters of PREPAK, (ii) one laptop with adapter, (iii) two nos. of mobile phones, (iv) one wallet containing a sum of Rs. 500/- (five hundred rupees), (v) one white envelope containing a sum of Rs. 5000/- (five thousand rupees), (vi) one loose Airtel SIM card.

On verification, the detainee identified himself as one **RK. Johney Singh @ Nganba Khuman (25 years) S/o RK. Sarat Singh of Top Khongnang Makhong Lane no. 10, Porompat Police Station, Imphal-East District** an active cadre of the outfit PREPAK joined through one Mr. Laiba of PREPAK in the year 2016 and got his basic military training in the same year for 45 days at Taka, Myanmar under the command of one s/s – Corporal Mr. Lanchingba of PREPAK with allotted army no. 1645001 of 45 batched. The detainee further stated that he is presently holding the rank of s/s Corporal and presently working under the command of one s/s – Major Khamba of PREPAK.

On further questioning, the detainee stated that on the advice of the said Mr. Khamba of PREPAK he had extorted a huge amount of money from various shop, govt. Officials & establishments for raising their party fund. So, the detainee was arrested from the spot i.e. Porompat DC Road near Water Supply Complex, Imphal-East District at 8:20 p.m. by observing due formalities by observing due formalities and seized; (i) 9 (nine) nos. Demand Letter of PREPAK duly signed by one s/s – Revenue Chief, Dept. Of Finance, Changkhonba Meitei of PREPAK, (ii) One Laptop (Dell), black in colour with adapter, (iii) one mobile phone (Redmi note 12) bearing IMEI no. 866588064728782 & 866588064728790 along with two SIM cards bearing mobile no. Airtel - 8414845668 & Jio -
