Officer in charge Porompat Police Station Imphal East, Manipur That since the last about 2 (two) years, the said WAL Club by taking the Law in their hands has been trying to allow the said Shri Angom Jamees Singh, to use the said common passage (LAMJANG) by organising mob and by committing mob lynching.

called true statement regarding the land dispute.

That in the earlier instances, when the accused persons and their men attempted to occupy the common passage, our Kolup constructed a gate on the southern edge of the common passage for safeguarding our lives and property, they attempted to destroy the same by organising a mob with the help of loud speaker and by making publicity. Seeing their illegal acts the members of our KOLLUP approached the Superintendent of Police, Imphal Police Station by filing the report dated 23-12-2023 to take up necessary action including promulgation of prohibitory order under Section 144 Cr.P.C. against the accused Angom James Singh and his party.

The Ld. District Magistrate, Imphal East also promulgated the prohibitory order dated 10th January, 2024 under Section 144 Cr.P.C. Even then Angom James, and his party came inside the common passage with the view to assault us but they disperse only on seeing the prohibitory order.

That I have never personally involved in the alleged dispute and is never a party in any of the court cases mentioned therein and the matters are now sub-judiced before the competent Courts. There is also no land dispute as alleged.

That in the said Public Meeting on 20.04.2025 resolution was adopted that I am responsible for the land dispute and resolved to Socially Boycott me and all the inhabitants of our Kollup from going inside the club premises of the WAL Club Community Hall and also to restrain me and all other inhabitants of our Kollup from using the Village Crematorium. In the meeting the above accused No. 2, 3, 5 and 6 are among the persons who presided the meeting.

That it was also resolved to make wide Publicity of these resolutions in the Print/Electronic media and to send the resolution to the Angom Leikai Shinglup and Wangkhei Ashangbam Leikai Shinglup. Accordingly the said resolution were announced in the ISTV on 22nd April, 2025.

That immediately thereafter, many well wishers have raised questions against me as to whether I have participated in any illegal and criminal activities and also started asking question as to why I had been socially boycotted. The accused have committed serious defemation against me without any basis.

That I and others are now facing social backlash and I am feeling physically and mentally insecure as in our present society of Manipur, a person who has been socially boycotted is faced with social stigma and looked down by the society. It has caused me great mental stress effecting my professional duty. The accused have conspired and colluded to adopt the esolutions as aforesaid, with the ulterior motive to harm my reputation, to make me mentally and physically insecure.

That as all the accused are of the same locality, I, with a view to bring an amicable settlement issued a legal notice dated 28-04-2025 by giving 7 (seven) days time to withdraw their resolution adopted on 20-4-2025 and to issue a public apology. However except for Shri Angom Nabakeshor Singh, one of the presiding person on the day of resolution, non of the accused had refused to make any apology.

The Wangkhei Angom Leikai Shinglup with the accused No. 4 and No. 7 as President and General Secretary has supported the illegal resolution of Social Boycott and has further resolved to boycott me and others from taking part in the activities of the Shinglup.

The accused and their followers are now instigating the inhabitants of Wangkhei Angom Leikai to raise against me and the inhabitants of our Kollup thereby promoting enmity between the people of Wangkhei Angom Leikai and the residents of our Kollup. including myself only with the aim and object to facilitate the accused, Angom Jamees Singh to allow him to use our Lamjang (common passage). They have also threatened, blamed and victimised me for approaching the courts by our Kollup. They have instigated the local people against me and the people of our KOLLUP and they are threatening our lives and properties. They are fully prepared for MOB Lynching against me, my family members and the inhabitants of our Kollup.

Now I have a great fear for my personal safety and for the safety of my family members and the inhabitants of our Kollup. There is also likelihood that the mob organised by accused may at any time and attack me and my family members. I am also feeling unsecure in attending to my official duties. Now I am attending office with the help of personal bodyguard as they are likely to assault me at any time, even to the extend of taking my life.

hat the present accused persons and their followers have committed offences punishable under various section of the BNS including cognizable and uncognizable offences

I am, therefore, to lodge the present report so that respected Sir, may register a proper FIR under appropriate sections of law and take up immediate action.

I am unable to file the report any earlier as I was trying to have the matter amicanly settled
