Sir,

I have the honour to report that today i.e. the 15th May, 2025 at about 2:30 p.m. received a reliable information from 165 TA (Territorial Army) & ECIB (Eastern Command Intelligence Battalion) corroborated with our own intelligence about the presence of one active member of the outlawed outfit KCP at Khurai Chingangbam Leikai, Imphal-East District. Based on the said information, a combined team of CDO/IE Unit and 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 3:30 p.m. at Khurai Chingangbam Leikai, Imphal-East District.

In that, one suspicious unknown person was detained for spot verification at Khurai Chingangbam Leikai, near DDK Imphal office, Imphal East District. On verification, the detainee identified himself as one Ngasepam Johnson Singh @ Manao (32) S/o Ng. Bashu Singh of Chingmeirong Mamang Leikai, Lamphel PS, Imphal West. On further verification, the detainee stated that he is an active cadre of the outfit KCP (City Meitei) group joined through one Mr. Charle of KCP (City Meitei) group in month of August, 2024 and got his basic military training for one month under the command of one Mr. Thoiba of KCP (City Meitei) group. He further stated that he is presently working under the command of the said Mr. Charle of KCP (City Meitei) group.

So, the detainee was arrested from the spot i.e. Khurai Chingangbam Leikai, near DDK Imphal office, Imphal-East District at 4:07 p.m. by observing due formalities and seized one mobile phone (Redmi Note 9 Pro Max) bearing IMEI no. 863118040970531 & 863118040970549 along with one Jio SIM card bearing no. 89918650400118110842 from his possession at the spot i.e. Khurai Chingangbam Leikai, near DDK Imphal office, Imphal East District at 4:10 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
