Joyraj Singh, MPS Addi. SP(Ops)Imphal-East rushed to the said area and conducted C. I. Ops. at the said area at

In that, one suspected person was detained for spot verification and checking at Andro Parking, Imphal East. On checking his body, two nos. of 9 mm ammunitions, two nos. of mobile phones and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one Loushigam Loveboy Singh @ Thoukanba (34 years) S/o L. Ningthemton Singh of Khundrakpam Makha Leikai, Heingang PS, Imphal East an active cadre of the outfit UNLF (Koireng) group. The detainee stated that he joined the outfit through one s/s Licutenant Mr, Manaoton of UNLF in the year 2013 and got his basic military training in the same year at Eastern Nagaland, Myanmar under the command of one s/s - Major Mr. Khongnangthaba for three months with allotted army no. 241 of 41st bathed. He further stated that he is presently holding the rank of s/s - Lance Corporal working under the command of one s/s - Major Wakheiba of UNLF (Koireng) group.

So, the detainee was arrested from the spot i.e. Andro Parking, Imphal East 7:59 p.m. by observing due formalities. Two nos. of 9 mm live ammunitions, one mobile phone (Nokia TA-1575) bearing IMEI no. 357891910685578 along with one Airtel SIM card bearing mobile no. 81189455485, one mobile phone (iphone 12) bearing IMEI no. 353053110225143 & 353053110258797 along with one Airtel SIM card bearing mobile no. 8798809594 and one wallet were seized from his possession by observing due formalities at the spot i.e., Andro Parking, Imphal East 8:05 p.m.

So, the detainee was arrested from the spot i.e. Khurai Konsam Leikai, Tharoijam Leirak, Imphal East at 9:13 p.m. by bserving due formalities and seized; one .32 Pistol along with one magazine and one mobile phone (Redmi 13 5G) bearing IMEI no. 868428063431740 & 868428063431757 along with one Airtel SIM card bearing mobile no. 6909161494 from his possession at the spot i.e. Khurai Konsam Leikai, Tharoijam Leirak, Imphal East at 9:20 p.m. by observing due formalities.

Thereafter, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
