Sir,

I am to state that today, i.e. 16/05/2025 at about 2.00 pm received an input from 4 Assam Rifles that suspected UG cadres are loitering in general area of Wangkhei Ayangpali area to commit prejudicial activities. On receiving the information, a team of special CDO unit under the command of L. Bebekananda Singh OC-SPL/CDO Unit, Khabeisoi including myself, under the supervision of Dr. S. Ibomcha Singh, MPS, CO 8th IRB & In-Charge special CDO unit rushed to the said area and conducted cordon and searched operation of selective houses in the suspected area at Wangkhei Ayangpali area.

During the search operation at about 3.30 pm one suspected person was detained for verification in a house of one Oinam Milan Singh. On verification, he disclosed himself as Oinam Milan Singh age about 53 yrs /O. Late. O. Kokngang Singh of Wangkhei Hijam Leirak. Further, he disclosed that he is the Project Officer of PREPAK-PRO and work under one S/S Lamtakpa of PREPAK-PRO. He threatened and demand to the many Government offices and Private sector to extortion money from the general public for party fund by using his vehicle A-Star B/R No. MN07D-0574 and 2(Two) Mobile having no. (i) AIRTEL sim Mobile No. 9774612477 and (ii) BSNL sim mobile no. 9436082620. Further questioning, he stated that, he was previously arrested (i) in the year 2007 by City Police Station, (ii) in the Year 2021 by Lamlai Police Station and (iii) in the Year 2024 by CDO-^{PO} respectively. On spot body search, 2 (two) mobile phones (I-phone-13 having IMEI no. 353825086391219 and i-phone-7 having IMEI no. 356452878219784), 200 rupees -1 no. , 100 rupees -2 nos. and one A-Star sky blue in colour was found from his possession. Hence, he was arrested at 4:24 PM from his Residence and seized the above articles at 4:30 PM by preparing legal formalities.

The arrested person and seized items are handed over to Porompat Police station for further necessary legal action.
