Sir,

I have the honour to report that on 19/5/2025 at about 4.30 pm my father namely of. Saroj Khan aged about 40 years of Khergao Awang Leikai forcibly kidnapped and wrongfully confined by some persons led by Yumkhaibam Nazakat aged about 35 years s/o Late. Md. Ibothem of Khergao Yumkhaibam Leikai from our residence located at Khergao Awang Leikai and he was kept concealed at Achumba Khongthang rehabilitation center Kongba without giving any reason. Further he (Nazakat) demanded a sum of Rs. 20000/- and one mobile handset for use of their organization. That, today i.e. 21/5/2025 at about 2.30 pm my father was rescued from the said Rehabilitation center with the help of local people. On enquiry, my father disclosed that he was assaulted by the said Mr. Nazakat and his associate by using deadly weapon. As a result my father received serious injury on his back, belly and some part of his person and he was evacuated to JNIMS Porompat for medical treatment. Now my father is undergoing medical treatment at the said Hospital. That, the act of Mr. Yumkhaibam Nazakat and his association abducted and wrongfully confined a persons with huge demanded money from the victim for their organization (YADA) fund.

It is therefore, requested to kindly take up necessary legal action against the above mentioned accused persons according to law.
