

13. **DETAILS OF CASE:** According to information from a reliable source that a large number of riotous members of Arambai Tengol and its supporter had vandalized government properties such as office buildings, public vehicles, roads, culverts including properties owned by general public during the period of general shut down called by Arambai Tengol from 7/06/2025 to 8:30 am of 10/06/2025 in different areas within the jurisdiction of Porompat Police Station thereby causing damage to Government Properties, threatening to the free movement of general public, wrongfully confining/restrain the general public. Thus the act of miscreant resulted in the economic loss of the term of Crores of rupees.

Hence, a regular case under FIR No. 133(6)2025 PRT-PS U/S 189 (2)/191(2)/191(3)/190/351(2)/126(1)BNS-2023, 3 PDPP Act & 7 Cril Law Amendment Act. has been registered on suo motu for investigation.

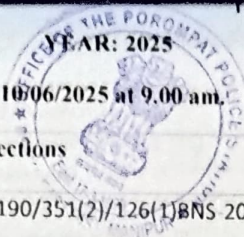
