I have the honour to report that on 15/6/2025 at about 4.26 pm my father namely Toijam Joy Singh aged about 67 years' s/o Late. T. Mani Singh of Wangkhei Koijam Leikai he was coming from Advance Hospital side towards Konungmamang on a two wheeler Wego bearing Regd. No. MN01Y-4179 was knocked down by four wheeler Ertiga white color without registration number at Palace Compound near Advance Hospital due to rash or negligent driving on the part of four wheeler Ertiga driver and fled away after commission of the crime from the spot. As a result of which my father received serious injury on his shoulder, head and some part of his body and he was evacuated to Shija Hospital Langol for medical treatment. And the two wheeler Wego was also partly damaged.

It is, therefore, requested to kindly take up necessary legal action against the unknown culprit according to law.




