Subject: Report.

Sir,

I have the honour to report yesterday i.e. the 18th June, 2025 at about 12:30 p.m. received an information about the presence of some active members of the outfit UPPK at Porompat area of Imphal East District. Based on the said information teams of CDO/IE led by myself under the command of Inspt. N. Devdas Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a random frisking and checking to the suspected passersby at Porompat near DC Office Gate at 1:00 p.m.

In that, one suspected person was detained for spot verification at Porompat DC Road near DC Office Gate, Imphal East District. On verification, the detainee identified himself as one **Pheiroijam Lalmohan Singh @ Iboyaima @ Thoi (33 years) S/o Ph. Khogen Singh of Takyel Kolom Leikai, Imphal-West District**, an active member of the outlaw outfit UPPK joined through one Mr. Naoba of UPPK in the year 2009 and got his basic military training for six month in the year 2010 with allotted army no. 165 of 28th batched at Taka, Myanmar under the command of one s/s - Coroporal Mr. Chingthang of UPPK. The detainee is presently working under the command of one s/s - Chairman Mr. Shanti of UPPK.

On further examination, it came to leant that the detainee used to threatened his family members and general public with grave consequences for allegedly defying arbitrary and unauthorised 'moral policing' directives by using unauthorised and illegal fire-arms which may lead to catastrophic consequences including injury, death, lifelong trauma. The act was intentional, unlawful, and carried out with complete disregard for the law and civil liberties. Such conduct poses a direct threat to public safety and constitutes a wilful attempt to undermine legal authority and democratic order.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Porompat DC Road near DC Office Gate, Imphal East District at 1:40 p.m.

The detainee further revealed that the firearm which he in threatening his family members and general public is being kept conceal at a paddy hut at Ngairangbam Maning Leikai, Imphal West. Immediately, our team along with the arrestee rushed used to the said place and on the instance and pointing of the arrestee recovered one country made semi-automatic gun without magazine and one magazine of 7.62 mm SLR. The recovered; **(i) One country made semi-automatic gun marked as '538336-87' without magazine and (ii) one magazine of 7.62 mm SLR** at the spot i.e. Ngairangbam Maning Leikai, Imphal West at 2:50 p.m. by observing all formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal procedures.
