t have the honour to report that today 22/06/2025 @ 12.15 am I was informed by my niece namely falak (12) years through my mother mobile phone bearing mobile no. 9383219434 stating that her mother namely Seema Shahni (42) years w/o Mujibur Rahaman of keikhu Maning Leikai had been attacked by sliting her throat with a sharp weapon inside her residentaial bed room by unknown person/persons while she was asleep. She also requested me to come as soon as possible to save her mother. Hearing the bad news, I rushed to her house. On reaching the place the family members were found trying to evacuated to her to hospital on a four wheeler schicle. Accordingly, I along with three persons namely Momocha (35) years D/o Jalin of Keikhu Maning Leikai and others two male members evacuated her to Advance Hospital for saving her life. On reaching the hospital the doctor had declared that she was brought death. It felt to me that there is foul play as the incident took place inside the house in presence of the family members regarding the
