Ranjit Singh of Kongba Laishram Leikai, Imphal East District, Manipur stated that he joined the said outfit organisation in May 2025, through one SS 2<sup>nd</sup> Lieutenant Mr. Naokhonba of PREPAK-Pro, who is in Myanmar. ii). Lourembam Kumar Meitei @ Kanto S/o. (L) L Ibomcha of Houbam Marak, Lourembam Leikai, Imphal West Dist. Manipur, A/P- Sawomgbung, temporary home/Relief Camp, Imphal East Dist, Manipur, stated that he joined the said outfit Organisation in the year 1995. He was once arrested in the year 2007 while returning from Myanmar. He was trained in the Konyak Camp of Myanmar. He was allotted with army no. 961005 of the 4<sup>th</sup> Batch, trained under NNC (a fraction of NSCN-Khaplang). After that, he came into contact with SS Dy. CO Erei of PREPAK-PRO of Myanmar Tamu Camp and continued to work under him. He also stated that he was involved in recruiting the new cadres and sending them to Myanmar. iii). Laishram Haridas @ Holaiba S/o. Laishram Mubi of Uripok Sorbon Thingnel, Imphal West Dist. Manipur stated that he joined in January 2025 through an SS Lieutenant of Tamjanganba of Lairenkabi and iv). Yumnam Akash Singh, S/o Y. Gopal Singh of Hiyanglam Awang Leikai.

Thereafter, based on their statements, corroborated with other evidence, they were formally arrested the under noted persons namely i). Thingbaijam Philip Singh, S/o. (L) Th. Ranjit Singh of Kongba Laishram Leikai, Imphal East Dist. Manipur at about 02:52 pm on 22/06/2025 ii). Lourembam Kumar Meitei @ Kanto S/o. (L) L Ibomcha of Houbam Marak, Lourembam Leikai, Imphal West Dist. Manipur, A/P- Sawomgbung, Temporary House, Imphal East Dist, Manipur at 03:07 pm on 22/06/2025 and seized one Mobile Phone VIVO 1907 Phn No. 6909631847 IMEI NO. 863720042884030 & 863720042884022 iii). Laishram Haridas @ Holaiba S/o. Laishram Mubi of Uripok Sorbon Thingnel, Imphal West Dist. Manipur at 03:15 pm on 22/06/2025 and seized Phn. No. 7005389277 POCO M6 5G Having IMEI No. 863922061855285 & 863922061855293 iv). Yumnam Akash Singh, S/o Y. Gopal Singh of Hiyanglam Awang Leikai from the Office of the Cyber Crime Unit/Technical Intiligence at 02:39 pm.

Upon further examination of the detainee, Lourembam Kumar Meitei @ Kanto, he disclosed the location of a hideout containing a large cache of arms and ammunition. Acting swiftly on this revelation, the team preceded to the identified location and, at the instance and pointing of Kanto, conducted an operation during which the following items were recovered from the one hut (Temporary camp) of the foothill of Irilbung Kalika, Imphal East, at 04:42 pm on 22/06/2025.

Sir,

I have the honour to report that, over the last few days, the combined team of Imphal East District Police and 21 PARA (SF) was working on reliable inputs of an unlawful organization operating in both the valley and hilly areas of Manipur. It came to light that a team of PREPAK-Pro operated in the valley area under the command of one SS Erie, who is staying in Myanmar, had looted many arms and ammunition from the Government armories, taking advantage of the prevailing situation of the State.

On 21/06/2025 at 10:00 am, the combined team led by Inspector Md. Rajib Khan, Technical Intelligence Unit IE/In-Charge Cyber Crime Unit IE, launched an operation based on information provided by Inspector Md. Rajib Khan, Technical Intelligence Unit IE/In-Charge Cyber Crime Unit/IE, assisted by N. Devdas OC-CDO/IE and his team, under the guidance of Shri. Rakesh Balwal, IPS Sr. SP/IE, under the Supervision of Y. Joyraj Singh, MPS, Addl. SP(Ops)IE.

In the operation, on 21/06/2025 at 10:30 pm, one person, namely Thingbaijam Philip Singh, S/o. (L) Th. Ranjit Singh of Kongba Laishram Leikai, Imphal East Dist. Manipur, was detained at Kongba Crossing near Meitei Mayek School.

Further, based on the above information, the combined team launched a counterinsurgency operation based on the statement of the Thingbaijam Philip Singh, S/o. (L) Th. Ranjit Singh of Kongba Laishram Leikai, Imphal East District. Manipur, till 02:00 am of 22/06/2025, the combined team detained another 3 personnel, namely i). Lourembam Kumar Meitei @ Kanto S/o. (L) L Ibomcha of Houbam Marak, Lourembam Leikai, Imphal West Dist. Manipur, A/P-Sawombung, Temporary House, Imphal East Dist. Manipur, ii). Laishram Haridas @ HOLAIBA S/o. Laishram Mubi of Uripok Sorbon Thingnel, Imphal West Dist. Manipur, iii) Yumnam Akash Singh, S/o Y. Gopal Singh of Hiayanglam Awang Leikai from the Irilbung Kalika area.
